Charging and Remissions Policy

Overview

All education during school hours is free. We do not charge for any activity undertaken as part of the National Curriculum, with the exception of some individual or small group music tuition. The school will ensure that on no occasion where charges may be levied, as for example, for residential or other visits, any pupil is disadvantaged solely by their inability to pay.

Voluntary contributions

When organising educational visits to enrich the curriculum and the educational experience of the children, the [academyschool](#) invites parents to contribute to the cost. All contributions are voluntary. If we do not receive sufficient voluntary contributions, we may cancel a visit. If a visit goes ahead, it may include children whose parents have not paid any contribution. We do not treat these children differently from any others.

If a parent wishes their child to take part in an educational visit or event, but is unable to make a voluntary contribution, we do allow the child to participate fully in the trip or activity. Sometimes the [academyschool](#) pays additional costs in order to support the visit. Parents have a right to know how each trip is funded. The [academyschool](#) provides this information on request.

The following is a list of additional activities, organised by the [academyschool](#), which require voluntary contributions from parents. These activities are known as 'optional extras'. This list is not exhaustive:

- visits to museums;
- sporting activities & outdoor adventure activities;
- visits to or by a theatre company;
- [academyschool](#) trips;
- musical events;
- transport;
- enrichment activities within [the academyschool](#) provided by outside agencies.

Residential Visits

If the [academyschool](#) organises a residential visit in school time or mainly school time, which is to provide education directly related to the National Curriculum, there is no charge for the education. However, a charge to cover the costs of board and lodging and a contribution for transport and activity costs will be sought. If parents are experiencing financial difficulty they are invited to discuss the matter in confidence with the [Principal/Head of School](#). Parents of children who are entitled to [Income-Related](#) Free School Meal funding (not government funded universal infant free school meals) are offered the option to make a reduced payment.

For visits made out of school hours, a charge equivalent to the full cost of the visit will be made.

Music tuition

All children study music as part of the normal school curriculum. We do not charge for this.

There is a charge for individual or small-group music tuition, since this is an additional curriculum activity, and not part of the National Curriculum. These individual or small-group lessons are taught by peripatetic music teachers. We make a ~~small ec~~charge for these lessons. If parents are experiencing financial difficulty they are invited to discuss the matter in confidence with the [Principal/Head of School](#). Children entitled to [Income-related](#) Free School Meals can apply for a subsidy.

Swimming

[Whitchurch CE Junior Academy/WJA](#) organises swimming lessons for all children. These take place in school time and are part of the National Curriculum. ~~No voluntary contributions will be requested in 2022-2023 as a temporary swimming pool will be sited at the Junior academy site in Spring 2023 and there are no transport requirements. A (voluntary) contribution is requested for swimming in order to help to cover the cost of the pool hire, lifeguard and the swimming coach. (obligatory when taking pupils to the Whitchurch swimming pool).~~

After school activities

The [academyschool](#) offers ~~s~~ additional activities after school. We reserve the right to make a small charge for these sessions.

Damage and Breakages

The [academyschool](#) may ask parents to pay for damage to school property or equipment where this is a result of a pupil's misbehaviour.

Infant Academy pupils benefit from Universal infant free school meals. Lunches cost £2.30 for a main course and dessert, a carton of drink is optional at 40 pence.
